- ♦ Our **Keynote Speaker** will be **Mario Cuomo**, the 52nd Governor of New York State.

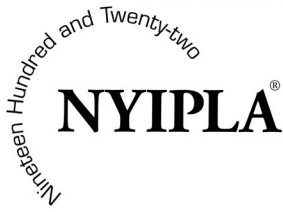
