SCP – Origins

- Created in 1998 to serve as a forum to discuss issues, facilitate coordination and provide guidance concerning the progressive international development of patent law.
- SCP discussions initially included *harmonization of national laws and procedures* (see SCP/1/2).

SCP – Evolution

- The work program of the SCP was dramatically recalibrated when an impasse emerged between developed and developing countries.
- To move beyond the impasse, Member States agreed to a “balanced work-plan”, which includes:
 - Exceptions and Limitations to Patent Rights.
 - Quality of Patents, including Opposition Systems (includes work sharing).
 - Patents and Health.
 - Confidentiality of communications between clients and their patent advisors.
 - Transfer of technology.

SCP – Major Challenges

- Brazil Proposal on a Manual on Exceptions and Limitations.
- GRULAC (Group of Latin American and Caribbean Countries) Proposal on WIPO Manual Update.
- Africa Group Proposal on Patents and Health (UN High Level Panel on Access to Medicines).

SCP – 28th Session (July 2018)

○ The Secretariat presented ..

- An updated reference document on the exception regarding acts for obtaining regulatory approval (*Bolar*).
- An updated Inventive Step study.

○ Member States shared experiences with ..

- Cooperation between patent offices in search and examination.
- Publically accessible patent information.
- Ensuring confidentiality of communications between clients and patent advisors.

SCP – Future Work (29th Session)

- **Scheduled for Dec. 3-6, 2018**
- **Agenda:**
 - The Secretariat will prepare a new document on the research exception to the patent right, as well as an expansion of the Inventive Step study.
 - Conference on publically accessible patent databases; sharing session by patent practitioners on experiences negotiating licensing agreements.

SCP – US Objectives


- **(Short Term) Focus the work of the SCP on technical matters of benefit to a broad range of offices and away from controversial issues that are impeding progress.**
- **(Long Term) Create an appropriate environment for, and acceptance of, resuming normative work (e.g., substantive patent law harmonization).**

Increased Worldwide Patent Filings by Chinese Entities

- In 2016, worldwide patent filings exceeded 3 million for the first time, an increase of 8.3% relative to 2015.
- This growth was driven overwhelmingly by China, which in 2016 received more applications than the U.S., Europe, Japan and South Korea combined.

Patent Filing Trends for the IP5 Offices







Growth in Patent Grants in China



Growth in Chinese Patent Grants

- Much of the growth has been in the areas of computer and medical technology, which increased by 62% and 20% respectively from 2015 to 2016.

PCT Filings by Chinese Residents

- In 2017, China was the second-largest source of PCT applications, closing in on the U.S.
 - **Since 2003, the annual rate of growth of PCT applications originating in China has exceeded 10%.**
 - **Both of the two entities who filed the most PCT applications were of Chinese origin.**

Other Matters

- EU proposal to carve out certain exceptions to *Supplementary Protection Certificates* (SPCs) (which serve to extend the term of certain EU patents for regulated products).
- October 23-24 dialogue with experts from other IP5 offices on patent subject matter eligibility.
