2010-11 YEAR IN REVIEW

PROLOGUE

The Association year actually got off to a head start vis-a-vis the Annual Meeting. Prior to that time, the Board engaged in extensive discussions regarding the possibility of bringing in a new Executive Director, what impact it would have on the Association, whether it was the prudent thing to do, and, if so, which choice would be most appropriate. In advance of the Annual Meeting, the Board decided to retain Robin Rolfe Resources to handle the administrative functions of the Association for a one year renewal option for the benefit of the Association.

The Board was aware of the risk associated with making this change, but decided that the reward to be gained outweighed the risk. As things turned out, the Board made a propitious decision.

SPRING INTO SUMMER 2010

The incoming President held a luncheon for the Association's incoming Officers and a dozen Past Presidents on the day of the Annual Meeting at Wiggin and Dana's mid-town office.

The purpose of the luncheon was two-fold: first, to introduce the attendees to Robin Rolfe and Feikje van Rein of Robin Rolfe Resources; and second, to gain insight from the Past Presidents as to their accomplishments during their administrations, and what they might have done differently, as a prelude to offering suggestions for initiatives for this year.

That evening, the Annual Meeting was held at the Union League Club of New York. It was a most enjoyable gathering in a classic, historic setting.

The June Board meeting was held in conjunction with a full day Board retreat at Wiggin and Dana's offices. The retreat served as a "brainstorming session" to help formulate and prioritize NYIPLA initiatives for the Association year.

An initiative for controlling Board costs involved having each Board member with a mid-town Manhattan location host a Board meeting at their firm. The financial savings was about a thousand dollars per Board meeting, as compared to meetings held at a university club. As an added plus, the Board members gained insight into each other's firm's facilities and setting. The net result was to enhance esprit de corps among Board members.

Another initiative involved strengthening the Board liaison role with the Committees. Each Board mem-

ber was requested to provide a monthly update on the progress of the Committee for which they have oversight responsibility.

The net effect was to streamline the functioning of the Committees, and to enhance individual Board members' participation at the Board meetings. By way of further streamlining, the number of Committees was cut by one-third in an effort to focus on core Committees.

As another initiative, a "Women in IP Law Committee" was formed to provide a forum for female lawyers' networking, and to encourage their increased participation in Association activities.

Yet another initiative involved implementing a suggestion by Alice Brennan to hold an "executive session" at the end of each Board meeting limited to Board members. These executive sessions encouraged frank and open discussion among the Board members.

Due to the timing of the change to a new Executive Director, the half-day Trademarks program, originally slated for mid-June, was rescheduled to mid-July. Despite coinciding with the peak of the summer vacation season, the program featuring Commissioner Lynne Beresford held at the Princeton Club was well-attended and well-received. Kudos to Anna Erenburg, Richard Parke and Dorothy Auth for this fine result.

The July Board meeting was held at Willkie Farr's offices. The Board supported a request to permit Goodwin Procter to prepare an amicus brief supporting neither party in the Federal Circuits *en banc* rehearing of *Tivo Inc. v. EchoStar Corp.* Association expenses were decreasing due to administrative changes, and increased use of electronic communications, that have been implemented.

By the September Board meeting at Wiggin and Dana's offices, it was clear that planning for the 2011 Judges Dinner was well underway.

FALL INTO WINTER

The October Board meeting at the Union League Club was preceded by a meeting among the Committee Chairs and Board. The reduction in the number of Committees permitted all available Chairs to sit around a table with the Board to have a cross-committee dialogue about plans for the year. This allowed for excellent communication across the spectrum of committee initiatives.

At the October Board meeting, it was announced that (1) Judge Arthur Gajarsa will receive the Outstanding Public Service Award; (2) a lifetime achievement award will be presented posthumously to Judge Giles S. Rich on the diamond anniversary of his term as NYIPLA President [1950-51], and (3) Judge John Gleeson from The Eastern District of New York will be the after-dinner keynote speaker at the event.

The Meetings & Forums Committee's October luncheon entitled "Important New Developments in International Prosecution and Enforcement" was held at the Harvard Club. It was geared to IP litigators and prosecutors alike. The program was well-attended and well-received. Kudos to Jay Anderson for this fine result.

The CLE Committee's Fall One Day Patent Program was held in November at the Princeton Club. The program had 135 registrants, and generated a profit for the Association.

The November Board meeting was held at Mintz, Levin's offices. Membership categories, and the sending of a "welcome letter" to all new members were agreed upon. The pricing structure for the Judges Dinner will be held at last year's Dinner's prices.

The Meeting & Forums Committee's December luncheon at the Harvard Club featured the Federal Circuit's Chief Judge Randall Rader as the speaker. It was well-attended and informative.

The December Board meeting was held at Ropes & Gray's offices. The Board discussed the naming of the NYIPLA law student diversity scholarship in honor of Judge Giles Rich, a Past President of the NYIPLA.

The Meetings & Forums Committee's January luncheon at the Harvard Club featured a lively discussion of the Microsoft v. i4i case pending before the U.S. Supreme Court.

The January Board meeting was held at Wiggin and Dana's offices. The Board discussed forums for the diversity scholarship. The 2010-11 scholarship was provided to Fordham Law's Susan Shin. For the 2011-12 scholarship, Cardozo Law is being considered. Launch of the NYIPLA's redesigned website is slated for the Spring.

The February Board meeting was held at Winston & Strawn's mid-town office. The Young Lawyers Committee plans to host a networking gathering at the Social Bar in Manhattan. In addition to the Inventor of the Year Award, it was decided to provide a Young Innovators Award at the 2011 Annual Meeting slated for May.

SPRING AHEAD

The March Meetings & Forums Committee luncheon at the Harvard Club focused on privacy law topics. The NYIPLA's efforts to reach "outside the box" with this topic helped to extend awareness of our Association among lawyers with non-IP specializations, and encouraged awareness by our members of the developing body of privacy law.

By the time of the March Board meeting at Baker Botts' offices, final preparations for Judges Dinner and Day of Dinner program were in full swing. Both programs were projected to be well-attended. Chief Judge Raymond Dearie of the Eastern District of New York agreed to be the keynote speaker at the Annual Dinner, and Judge Barbara Jones agreed to present awards to the Conner Writing Competition winners.

The 2011 Judges Dinner at the Waldorf went exceptionally well. Judge John Gleeson gave a brilliant and funny keynote speech. It was relevant to IP law, and of interest to the wider audience. It was perhaps the best keynote address in living memory.

Judge Arthur Gajarsa's acceptance of the Outstanding Public Service Award was most gracious. It was followed by Judge Giles Rich's granddaughter's acceptance of her grandfather's Lifetime Achievement Award. By virtue of her great-grandfather's having attended the NYIPLA's first Judges Dinner in 1922, the circle of the Rich family's participation in our annual Waldorf event was completed.

The April Board meeting at the Union League Club was preceded by a gathering with Committee Chairs to discuss their accomplishments for the year. It was noted that the Judges Dinner had increased attendance year-over-year. Preparations for the JPP CLE gathering and for the Annual Meeting were in their final stages.

By all accounts, it was a most productive and rewarding Association year.

EPILOGUE

The Association's financial condition improved by a full twenty four percent, year-over-year.

In the days leading up to the Annual Meeting, the Board was called upon to engage in a dialogue regarding the Association's By-Laws, and if and how they might be improved over time. This dialogue served to further enhance the esprit de corps among the Board members.

Thanks to all Board members and to all Committee Chairs for having made this year a bright and shining moment in our Association's history, as the future is bound to show.






NYIPLA Diversity Scholarship Award

The Amicus Briefs Committee coordinates the activities of the Association relating to the preparation and filing of amicus briefs and makes recommendations with respect thereto to the Board of Directors. During the past year, over a dozen proposals for amicus curiae briefing by the Association were presented to the Amicus Briefs Committee by interested parties, and two additional proposals were initiated by members of the Committee. The Committee made recommendations to the Board that seven briefs amicus curiae should be filed, five in the Supreme Court of the United States and two in the Court of Appeals for the Federal Circuit.

During this time, the Federal Circuit issued decisions consistent with the Association's previous amicus filings in *Princo v. ITC* (*en banc*) involving patent misuse, in *Hyatt v. Kappos* (*en banc*) involving evidence in Section 145 lawsuits, and in *Tivo v. Echostar* involving contempt proceedings. The Supreme Court explicitly referred to the Association's amicus brief in its *City of Ontario v. Quon* decision involving the extent of privacy rights for communications in work-related settings. The *John Wiley & Sons v. Kirtsaeng* case involving copyright exhaustion, in which the NYIPLA also filed an amicus brief, is still pending before the Court of Appeals for the Second Circuit.

Conner Writing Competition

Scope of the Committee: To publicize and conduct a law school writing competition on an intellectual property law topic, and to make recommendations with respect thereto the Board of Directors.

The Committee solicited and reviewed entries for the William C. Conner Writing Competition. We worked with Robin Rolfe Resources to prepare and post the announcement of the competition on the NYIPLA website in December, update the database of e-mail addresses and create an electronic spreadsheet with information for the intellectual property contacts (professors or deans) at each of the eligible schools. An e-mail was sent by the Board liaison to the contacts to encourage that the writing competition announcement be posted at the school to ensure the students were aware of the opportunity.

We received 46 submissions which represented a significant increase over prior years. Each Committee member reviewed the submitted materials and a teleconference was held to make a first cut. Twelve papers were identified for further consideration. Each Committee member re-read the 12 papers and ranked his or her top three submissions. A full Committee meeting was held to discuss the rankings and a consensus was reached with respect to the top recommendations. The top four recommendations were sent to the NYIPLA Board for its consideration.

It has been our pleasure to serve as Co-Chairs of the Committee on Continuing Legal Education this year.

NYS CLE ACCREDITED PROVIDER STATUS

The New York Intellectual Property Law Association ("NYIPLA") initially was certified by the New York State Continuing Legal Education Board as an Accredited Provider of continuing legal education ("CLE") in the State of New York on September 1, 1999. All of our live CLE courses and programs given from August 1, 1997 up to August 27, 1999 were retroactively approved. As of January 11, 2000, the NYS CLE Board approved our application for non-traditional formats for videotapes. Videotaped CLE courses and programs given from August 1, 1997 were retroactively approved. Approval of the non-traditional CLE format (DVD) was received August 15, 2005. Certification was approved for the period April 27, 2004 through August 27, 2005.

Our Application for Renewal of Accredited Provider Status was submitted to the New York State Continuing Legal Education Board on January 30, 2008. Approval as an Accredited Provider of CLE programs for the period of August 28, 2008 through August 27, 2011 was renewed on November 5, 2008 for the following formats:

- Live classroom, for group participation;
- DVD, for self-study (individual participation); and
- Videotape, for self-study (individual participation).

We continue to provide educational courses that satisfy NYS CLE credits in accordance with NYS Rules, Regulations and Guidelines.

In compliance with the requirements of the New York State CLE Rules and Guidelines, we also filed an annual report with the New York State CLE Board on January 14, 2011 covering the 2010 calendar year.

This year the Committee continued the CLE program series in conjunction with NYIPLA's Annual Dinner in Honor of the Federal Judiciary at the Waldorf-Astoria on March 25, 2011. Special invitations were sent to the Honored Guests attending the dinner. A distinguished panel, including four federal judges, presented a well-received discussion. The program had a total registration of 153, including thirteen federal judges.

2010 - 2011 Committees

Since last year's report, NYIPLA has sponsored 7 CLE programs totaling 8 credit hours of legal education. Our videotape library currently contains 3 credit hours of NYS CLE programs for NYIPLA's calendar year which are made available to NYIPLA members, members of the bar, law firms, and corporations.

During the program period (May 1, 2010 thru April 30, 2011), NYIPLA awarded approximately 19 NYS CLE credits, including approximately one ethics credit, and approximately eighteen professional practice credits. In addition, there were approximately 533 attorneys who attended CLE programs during this program period.

We continue to price programs as reasonable as possible to cover necessary costs. There were four financial aid requests granted in 2010-11 in the form of four partial scholarships.

EXCELLENT ADMINISTRATIVE SERVICES OFFERED BY ROBIN ROLFE RESOURCES, INC.

All of the CLE-related administrative functions continued to be centralized with Robin Rolfe Resources, with systems and procedures in place to provide continuous, coordinated support. This includes scheduling; communications with the hosting committee's program chairs, speakers and attendees; preparation and mailing of meeting notices; registration processing; preparation of Certificates of Participation, Course Evaluations and Certificates of Attendance under the direction of the CLE Committee Chair; logistical planning and coordination; and providing video/DVD program availability. Robin Rolfe Resources also assisted in the preparation of the year-end report to the NYS CLE Board and the accredited provider renewal application and audit. Robin Rolfe Resources continue to use a broadcast e-mail system, which provides greater flexibility in communicating up-to-date CLE program information to our members.

Robin Rolfe Resources, Inc. has provided excellent administrative services in support of the CLE program.

COMPLIANCE

NYIPLA has moved aggressively to continue compliance with substantially expanded CLE procedures which include new requirements as to the format and content of the Certificate of Participation, the substantiation of the registration procedure, and the monitoring of program attendance.

CONCLUSION

It has been our pleasure serving this year as Co-Chairs of the Committee on Continuing Legal Education. It is our hope that NYIPLA continues an aggressive approach to continuing legal education programs, whose goal is to meet and exceed the needs of the intellectual property bar.

In addition, it would not have been possible for the Committee to achieve such successful CLE programming without the excellent support of the individual members of the Committee. These members have devoted extensive time and effort in planning programs and arranging for speakers and content: Karen Axt, Amy Benjamin, Jessica Copeland, John Halski, Wan Chieh (Jenny) Lee, Richard Margiano, Tod Melgar, Sonja Keenan, Debra Resnick, Mary Richardson, Irena Royzman, Keith Zullow, and Board Liaison Dorothy Auth. The NYIPLA Patent Litigation Committee communicates to the NYIPLA membership information on recent developments affecting patent litigation practice, including recent cases, statutes, proposed legislation, local rules, etc. This year, members of the Committee have submitted articles for publication in the Bulletin covering the litigation related aspects of the pending patent reform legislation and the effect on litigators of the recent decisions involving patent damages. Both of these topics are likely to be of significant interest to the membership and beyond and could form the basis for a CLE program in coordination with the Continuing Legal Education Committee.

On the patent local rules front, the Committee reviewed and commented on the patent local rules proposed for the District of Connecticut, which were largely modeled on the Northern District of California local rules. In addition, it is an ongoing Committee project to update and publish a comparison of the patent local rules promulgated around the country and to consider recommending patent local rules to the Southern District of New York.

On the legislative front, H.R. 628, aimed at establishing a pilot program for educating and increasing patent expertise for certain district court judges, has moved through Congress and will be a subject for ongoing Committee study.

Overall, this has been a productive year for the Committee, but much remains to be done.

The Privacy Law Committee devoted many meetings this year to considering emerging issues in the law, focusing in particular on developments concerning the practice of "behavioral advertising": namely, the tracking of individual computer users' on-line activity for the purpose of delivering advertising targeted to the users' patterns of conduct. Behavioral advertising has been the subject of increasing interest by the FTC, which is weighing new regulations, as well as the United States Commerce Department, which is seeking to establish consistent policies and better coordinate government response to these new challenges to individual privacy, both among the states that have legislated in the area and foreign privacy regulations. Moreover, there are now at least two significant pieces of bipartisan legislation pending in Congress – the "Commercial Privacy Bill of Rights Act of 2011" (S. 799), sponsored by John

Kerry and John McCain, and "Consumer Privacy Protection Act of 2011" (H.R. 1528), sponsored by Cliff Stearns and Jim Matheson. Further, there is legislation pending in certain states, most notably California, where a bill (S.B. 761) would give consumers broad new rights to opt out of such tracking, including a private right of action. California previously has led the way in the development of privacy law, including broad legislation limiting spam emails, which led Congress to pass the CAN-SPAM Act, preempting the California law and creating national standards. It is conceivable a new California law would hasten federal action to establish uniformity.

On March 1, 2010, the Privacy Law Committee hosted a CLE program at the Harvard Club entitled "FTC Report: Protecting Consumer Privacy in an Era of Rapid Change." The panelists were the New York Regional Director of the Federal Trade Commission, and three NYIPLA members. I served as the moderator. The panelists discussed in particular the FTC's December 2010 report, "Protecting Consumer Privacy in an Era of Rapid Change." The FTC recognizes there are considerable benefits to allowing such advertising, given that so much of the content available on the Internet is paid for by advertising. On the other hand, the FTC (and many consumer groups) are concerned about the potential dangers to consumers in tracking individuals' conduct — particularly insofar as it concerns sensitive queries and activities (e.g. regarding medical or financial matters) and insofar as such information can be personally identifiable. Using such tracking methods, advertisers are, indeed, able to develop highly detailed profiles of individual users. Even if such data is tracked only by IP address rather than individual name, advertising firms increasingly have at their disposal the ability to de-anonymize the data and conduct such tracking without the computer users' knowledge or meaningful consent. One of the most controversial proposals being considered by the FTC is to require a "do-not-track" option (modeled on the FTC's "do-not-call" registry), under which consumers could set their Internet browsers to block tracking.

Because of continuing high levels of interest in the subject, including bipartisan efforts in Congress to regulate the area, the Privacy Committee is continuing to monitor developments, and I am currently preparing a more complete report, to be published in the NYIPLA Bulletin, summarizing these developments and discussing them in greater detail. The FTC is eager to establish a mechanism whereby consumers can exercise greater control or meaningful choice over the data collected (particularly sensitive data); to limit data retention by internet advertisers; to control the sharing (or sale) of such data beyond the scope of any original consent, and to allow consumers greater access to and control over what data is being collected about them. Although the two principal bills pending in Congress do not include the "do not track" option, both seek to give individuals far greater control than they (we) now have to control use of personally identifiable data and seek to give the FTC broad rulemaking and enforcement powers. A third bill in Congress and the California legislation mentioned above do include provisions establishing a do-not-track mechanism. By continuing to monitor these developments, the Privacy Law Committee will continue to seek opportunities to publish informational pieces on the subject, conduct additional CLE programs, and perhaps exert some influence on these new legislative developments. Having recently agreed to continue as Chair of the Privacy Law Committee for the coming year, I hope to maintain a continuing focus on these and other developments in the area of privacy law, which I hope will broaden the base of interest (and membership) in the NYIPLA generally among members of the bar.

The Committee published the NYIPLA Bulletin on a bi-monthly basis. The Greenbook was replaced by online posting of Association information on the NYIPLA website (www.nyipla.org), together with information contained in this Green Booklet.

The Bulletin is a journal of articles of interest to the intellectual property community written by Association members. Articles in the Bulletin during this year covered a wide range of topics including patent false marking, the Supreme Court's *Bilski* ruling, inequitable conduct in light of the *Exergen v. Wal-Mart Stores* ruling, the standard of intent required for finding induced infringement, the common interest doctrine, patent eligibility of isolated nucleic acids, reverse payment terms in ANDA settlement agreements, patent damages, and analyses of the pending patent reform legislation.

US Bar - Japan Patent Office

The US Bar – JPO Liaison Council, comprising delegates from approximately 30 U.S. intellectual property organizations, usually meets annually as a users group with high officials of the Japan Patent Office. Typically, each side makes presentations on subjects of interest to the other side in the fields of patent law, practice and harmonization.

In 2010, the Council Chair-designate suddenly retired from the practice of law and was no longer interested in serving the Council. An informal committee sought new leaders and in October 2010 a strong team of new leaders was elected, including Jim Forstner as Chair, Mark Guetlich as the Vice Chair, and Chen Wang as Secretary and Treasurer. The Council also adopted new Bylaws at the same meeting.

It was not practical to schedule a meeting with the JPO in 2010 or early 2011; however, a delegation of approximately 12 Council members will meet with the JPO in Tokyo on June 1, 2011.

Japanese topics on the agenda include: JPO Office Update: Revision of grace period for activities by/on behalf of applicant prior to application filing, including advance declaration by the applicant at time of filing; a Patent Prosecution Highway status report; comparative discussion of inventive step/obviousness, including JPO inventive step guidelines and Japanese court application of inventive step law; requirements for description and claims, including enablement and written description requirements, including the JPO's restriction on new matter to satisfy written description requirement; the standard of proof required by the JPO for utility in chem/biotech applications; and the JPO's literal translation requirements.

In addition to comparative discussions of some of the Japanese practice topics, U.S. topics to be discussed include: the US America Invents Act of 2011; USPTO policy under David Kappos; September 2010 USPTO Guidelines on the *KSR* case; and "After the *Bilski* case."
