

NYIPLA is pleased to announce that the 100th Annual Dinner in Honor of the Federal Judiciary will be held at the **New York Hilton Midtown** on **Friday**, **March 25**, **2022**.

New York Hilton Midtown provides an opportunity to consolidate most of the dinner tables into one **Grand Ballroom** on the 3rd floor to provide Honored Guests, NYIPLA members and their guests with a view of the dais and a more collegial atmosphere. The Grand Ballroom can accommodate tables up to 10 people.

We encourage you to reserve your dinner table before **Thursday**, **February 17**, **2022**. Hospitality suites need to be reserved before **Friday**, **January 28**, **2022**.

Dinner Online Reservation

As the firm's designated Judges' Dinner Liaison, you have a username to access the Judges' Dinner <u>Table Registration Page</u>. This will allow you to enter the type and number of tables, add and edit names of attendees, and view and pay your invoice. **After February 17, 2022, revisions may only be submitted once a week on Tuesdays.**

Complimentary Membership

Each Table Package includes complimentary NYIPLA memberships for the May 2022 - April 2023 year. Platinum Packages provide five (5) complimentary memberships per table, Gold Packages provide four (4) complimentary memberships per table, and Silver Packages provide two (2) complimentary memberships per table.

Payment

Payment must be received in full by mail with the <u>Table Reservation Form</u> or <u>ONLINE</u> by Thursday, February 17, 2022. The table fees including descriptions for each Table package can be viewed <u>BELOW</u>. A 3% processing fee will be charged for all credit card transactions.

Refunds

Requests for refunds received after Thursday, February 10, 2022 cannot be honored.

Honored Guest Seating

The Judges' Dinner Committee will distribute all Honored Guest invitations and assign their seating. The Association <u>will not accept</u> invitations made by individuals or firms. The committee will do its utmost best to accommodate reservations but cannot guarantee all requests due to the number of Honored Guests. A printed seating list will be available in the Rotunda, 3rd floor and lobby area. The seating list will show the names of all guests for whom reservations and payments have been received by **Thursday**, **February 17, 2022**. **No exceptions will be made**.



Color

Content

Content is limited to appropriate expression of honor to the award recipient. Please observe the following content rules:

- No commercial content, tag lines or promotional language
- No photos or stock photography
- No full addresses or telephone numbers. Cities in which offices are located may be listed, for example "New York, Los Angeles, Milan"
- No individual names of company personnel
- No e-mail addresses
- Firm logo and website address permitted

Cost

Congratulatory Notice is reserved for and included in the Platinum and Gold Table fee.

Deadline: Thursday, February 17, 2022

Submission

Electronic Formats

TIF and EPS: Copy can be generated and produced as an image and saved as a .tif or .eps file. The resolution should be 300 dots or pixels per inch (dpi or ppi).

PDF: Copy can be supplied in a high-resolution Portable Document Format (PDF)

Final Approval

All submissions are subject to the review and approval of NYIPLA in its sole discretion.

Size

Vertical. Full page only, 1 side. Paper size is 6.5" x 10" with margins of 1" top and bottom, 3/4" left and right. No spreads.
